1. The abovementioned Notice of Intent ("NOI") dated July 2024 compiled on your behalf by your appointed Environmental Assessment Practitioner ("EAP"), Ms. Samantha Teeluckdhari (EAPASA No: 2023/6443) of Ecoroute Environmental Consulting, ("Ecoroute") as received by the Directorate: Development Management (Region 3) ("this Directorate") on 1 July 2024, refers.	
2. This letter serves as acknowledgement of receipt of the abovementioned report on 1 July 2024.	Noted.
3. The Directorate: Development Management (Region 3) ("this Directorate") has reviewed the information in the NOI and provides the following comment:	The EAP is not aware of the information received by the Department in the past; however, the activity being applied for is subject to a Basic Assessment process.
3.1. The proposal

According to the information provided in the NOI the proposal entails the establishment of an additional 11ha of agricultural fields for the cultivation of macadamia and avocado trees on Erf 385 in Hoekwil. Furthermore, it is understood that the proposal it is also proposed to develop an irrigation system (drip irrigation) within the fields to water the trees. 3.2. Process to obtain environmental authorisation Based on the information submitted to this Directorate a Basic Assessment process must be followed in order to apply for Environmental Authorisation. Only those activities applied for shall be considered for authorisation. The onus is on the proponent / EAP to ensure that all the applicable listed activities are applied for and assessed as part of the Scoping and Environmental Impact Reporting process. NOTE: This Directorate has previously received information which suggests that activities listed in Environmental Impact Assessment Regulations, 2014 ("EIA Regulations, 2014") Listing Notice 2 may be triggered. In this regard, please be advised that the success of an application for environmental authorisation may be prejudiced should it be found that the incorrect process is followed.	
With due consideration of the location of the proposed fields, this Directorate believes that not all listed activities may have been identified by the EAP. In this regard the following must be considered:	The EIA application and BAR have included the correct Listed Activities.
Associated structures and infrastructure crossing a watercourse: From the relevant GIS data and confirmed by the aquatic specialist there is a perennial watercourse (unchanneled valley-bottom wetland) present along the western boundary and a non-perennial watercourse along the eastern boundary of the proposed field. In this regard, it is understood that infrastructure for the irrigation of the proposed fields are required and based on the location of the dams (and existing infrastructure) the proposed new irrigation infrastructure may have to cross the watercourse along the western boundary of the proposed fields.	
In light of the above, consideration should be given to the applicability of Activities 12 and 19 of Environmental Impact Assessment Regulations, 2014 ("EIA Regulations, 2014") Listing Notice 1 for the development of infrastructure (including roads) within a watercourse. In this regard, the alignment of the proposed infrastructure must be depicted on a Site Development Plan ("SDP").	
Access Roads: The watercourse along the western boundary also isolates the proposed new fields from the existing orchards to the west. In this regard, it is unclear where access to the proposed new fields will be obtained from and what the required specifications for such access road are.	There is an existing access road crossing the western wetland; however, it would need to be upgraded as it has been completely inundated and revegetated by wetland plant species.

In light of the above, consideration should be given to Activity 4 of EIA Regulations, 2014 Listing Notice 3 for the development of access roads to the proposed fields. Furthermore, the access roads must be depicted on the SDP.

Agricultural Theme	Noted. A soil scientist was appointed in order to meet the requirements of the protocols.
	Further information is contained in the BAR.
According to the Screening Tool Report ("STR") submitted with the NOI the	
sensitivity rating for the Agricultural Theme is HIGH. According to the SSVR a Soil	
Classification Assessment was compiled which identified the cultivation zones, relevant soil types, soil depth, cultivation capability, etc. This assessment appears	
to have been commission for business planning purposes. Furthermore, the SSVR	
indicates that the proposal will continue to be used for agricultural purposes and	
will therefore not result in the loss of agricultural production potential.	
Notwithstanding, the findings of the report and the EAP's recommendation that no	
further study is required, the report does not fully comply with the requirements of	
a SSVR nor the Protocol, and the EAP's conclusion is contrary to the requirements	
regarding the minimum information requirement set in the Protocol for this theme.	
The sensitivity rating is not clearly disputed, however, based on the available	
information it is assumed that the EAP regards the sensitivity rating to be "Medium".	
In this regard, you are advised that if the sensitivity rating is regarded to have a	
"medium" or "low" sensitivity rating, then as a minimum, a soil scientist or	
agricultural specialist registered with the SACNASP, must undertake the assessment	
and prepare an Agriculture Compliance Statement which must inform the BAR,	
and be appended thereto.	
Nonetheless, the EAP must consult the Western Cape Government: Department of	
Agriculture (DoA) - Land Use Management and LandCare in the public	
participation process and specifically obtain written confirmation from said organ	
of state regarding the delineation of the theme as well as the requirements for any	
agricultural protection measures.	
Animal Species Theme	The relevant report has been included in the BAR.
The STR specifies a HIGH sensitivity rating for the Animal Species Theme. According	
to the SSVR two Species of Conservation Concern ("SCC's") were recorded in the	
study area, and a further four SCC's may be present due to the habitat present on	
the site and surrounding area. The SSVR indicates that an animal species specialist	
was been appointed and that an Animal Species Assessment Report has been	
compiled.	
In light of the above, this Directorate acknowledges that an Animal Species	
Assessment will be undertaken and Animal Species Assessment Report will be	
submitted. It must be ensured that the report complies with the requirements of the	
Terrestrial Animal Species Specialist Assessment as stipulated in the protocol.	
Aquatic Biodiversity Theme	The relevant report has been included in the BAR.

The STR specifies a VERY HIGH sensitivity rating for the Aquatic Biodiversity Theme. According to the SSVR there are unchanneled valley-bottom wetlands which borders along the eastern and western sides of the proposed fields. The sensitivity rating has not been disputed in the SSVR but it is indicated that and Aquatic Biodiversity Assessment has been undertaken. In this regard, it must be ensured that the assessment report complies with the requirements for the Aquatic Biodiversity Impact Assessment as stipulated in the protocol.	
Archaeological and Cultural Heritage; and Palaeontological Themes The procedure for site sensitivity verification where no specific assessment protocol	Noted.
has been prescribed, has been gazetted in Government Notice No. 320 of 20 March 2020. In this regard it is noted that Heritage Western Cape ("HWC") has been consulted and that said authority has indicated that no further studies are required. The correspondence dated 18 April 2024 (HWC Case No: HWC24030717SB0326) refers in this regard.	
Civil Aviation Theme	Noted.
The STR specifies a MEDIUM sensitivity for the Civil Aviation Theme. The EAP disputes the sensitivity and recommends a Low sensitivity as the proposal is located approximately 29km from the Airports Company South Africa: George Airport and will not have any impact on civil aviation. In light of the aforementioned, this Directorate acknowledges the findings of the SSVR. Nonetheless, the EAP must consult the SACAA (% Ms. Lizell Stroh at E-mail: Strohl@caa.co.za and / or Tel: (011) 545 1232) in the public participation process and specifically obtain written confirmation from said organ of state regarding the delineation of the theme, and necessity for any further studies regarding the Civil Aviation Theme.

The STR specifies a MEDIUM sensitivity in terms of the Plant Species Theme. With reference to Section 4.6 of the Plant Species protocol, please be informed that where SCC are found on site or have been confirmed to be likely present, a Terrestrial Plant Species Specialist Assessment must be submitted in accordance with the requirements specified for "very high" and "high" sensitivity in the protocol. The STR specifies a VERY HIGH for the Terrestrial Biodiversity Theme. The SSVR does not dispute the finding and indicates that a terrestrial biodiversity specialist was been appointed to conduct a site visit and compile an assessment report. In this regard, the assessment report must adhere to the requirements of the Terrestrial Biodiversity Impact Assessment as stipulated in the protocol.	
Combining specialist studies / reports	Noted and complied with.
Kindly note that it to combine the requirements of two or more protocols in a single report. However, it must be ensured that the report addresses the all the minimum information requirements of all the relevant themes as specified in the respective protocols. EXISTING WATER USES ON THE PROPERTY: According to the information in the NOI property has water use rights and a dam on site. Furthermore, it has been reported that there is a Water Use License ("WUL") and the authorised volume for the relevant water uses in the WUL is adequate for the proposed development. The proponent has attached documentation from the Department of Water and Sanitation to the NOI.	A Validation and Verification of 21 (b) Water Use on Erf 385 Hoekwil was submitted together with a Section 35(1) Notice to BOCMA. We are awaiting the written ELU. Please see Appendix L of the BAR.
A review of the documentation indicates that the document is not a WUL, but a National Register of Water Use Registration Record 29008038 dated 3 October 2018	

which merely indicates that there are water use activities registered on the property

However, the review of the document suggests that at the time of the issuing of the	
registration record that the lawfulness of the water uses is still to be determined. A	
review of the relevant aerial imagery and analysis thereof suggests that the some	
of the dams (17 000m3 dam and 15 000m3 dam) have been filled in and the area converted to cultivated fields. Furthermore, the 20 000m3 and 7 500m3 dams have	
been combined to form one large dam of which the volume has not been	
specified.

The aerial imagery suggests that there also is a dam located at approximate	
coordinates: Latitude: 33°57'10.97"S Longitude: 22°35'09.66"E. However, the dam is	
not listed on the National Register of Water Use Registration Record 29008038 dated	
3 October 2018 and the volume thereof is unknown.	
In light of the above, correspondence from the relevant authority i.e. the Breede-	
Olifants Catchment Management Agency ("BOCMA") is required regarding the	
lawfulness of the water uses on the property.	
POSSIBLE NEW WATER USES:	Noted. The EAP and relevant specialist are in contact with BOCMA to submit an
	application for General Authorisation. The process is underway.
Notwithstanding the above, according to the information available to this	
Directorate the proposed development will be located within the "regulated area	
of a watercourse" as defined in the General Authorisations in terms of Section 39 of	
the National Water Act, Act 36 of 1998 for water uses as defined in Section 21(c) or

(a) the outer edge of the 1 in 100-year flood line or delineated riparian habitat,
